CHAPTER BY LAWS ARTICLE XII: ADVANCE OUTING DEPOSIT

This fund shall be created by having each participating member/coach submit a one time refundable amount of \$10.00 to the Chapter Treasurer. The expenditures from this fund will be used for advance outing deposits that are required and will be paid from this fund at the discretion of the Wagon Master for the designated scheduled outings with the approval of the Chapter President and Treasurer.

In the advent that the participating member/coach withdraws from the San Juanderers Chapter their \$10.00 Advance Deposit will be refunded upon written request.
